## **Information Pack**

### Partners' Roles and Responsibilities:

The partners so appointed by the Prophet have roles below to perform:

- 1. Be born again, Spirit filled, heavenly focused, God fearing and ready to serve God.
- 2. Key into the vision of the ministry.
- 3. Non-Nigerian resident partners must participate in online prayer events and crusade programs.
- 4. Nigeria based partners must support and attend the physical and virtual programs.
- 5. Shun every act of disunity among partners and the ministry
- 6. Support the leadership of GMPM partners locally and globally.
- 7. Be faithful in performing any functions that may be assigned by the leadership of the partners' forum.
- 8. Respect the leadership of the partners' forum and accord every partner due respect.
- 9. Every partner is expected to make monthly financial commitment as at when due.

#### **Structure of Partners' Organization**

Glorious Generation (GG) Partnership's overall management will be under the office of the International board of trustee located in Lagos Nigeria under the leadership of the global chairman and the assistant chairman of the global executive team. They shall direct the affairs of the group in consultation with the visioner; Prophet Sam Olu Alo. There shall also be national coordinators and assistants appointed to oversee all activities of partners in each nation where the ministry has parishes. The national offices will have substantive secretaries and assistants to create and maintain proper records of the activities of the group. The national offices shall be reporting to the office of the Global chairman. The global and national leadership of the partners shall then form the executive committee of all partners worldwide.

**Termination of Partner's Membership:** It should be noted that any partner can lose his membership if:

- ✓ He/she is found wanting of gross misconduct(s).
- ✓ He/she choses to withdraw his/her membership. This should be communicated to the partners' forum leadership either in writing, call or via SMS
- Failure to attend meetings of the partners or ministry for three (3) consecutive times automatically ends one's membership of the partners' forum
- ✓ The visioner, Prophet Sam Olu Alo, reserves the right to remove any partner from the forum.
- ✓ Though we have covenant of life in this forum and God has been faithful in keeping this; the death of any partner automatically ends his/her membership.

#### **Terms and Conditions**

- 1. Partners must complete the partner's application form before admission, subject to recommendation of the global executive for interim approval that will be followed by a probation period of 3 months. After satisfying the conditions of the probational period partners will be presented to the prophet for final approval into the partner's group.
- 2. Partners are expected to complete the online form for their designated group before acceptance to the partner's platform.
- 3. It is the responsibility of partners to provide the relevant information required for the application process.

- 4. Partners are required to attend global and zonal meetings; either periodic or at the discretion of the leaders.
- 5. Partners must attend weekly prayer meetings and monthly vigil for their designated zones.
- 6. Partners are required to fast and pray once in a week for the Prophet and the ministry; Grace of Mercy Prayer Mountain Int'l.
- 7. Partners are encouraged to join sub- groups such as choir, intercessory and welfare team in their local zones.
- 8. Partners application process will be done quarterly. All applications that comes in within a quarter will be treated together. (e.g., Quarter 1= January to April application will be processed in April).
- 9. Partners (verified) can refer a person that is well known to them who intend to join the partner's group, such a partner will be the guarantor for the person they refer.
- 10. Partners must complete the probation period before they receive the designated contact number for the Prophet.
- 11. The Partner's designated number for the Prophet MUST never be shared with anyone. Failure to comply with this rule will lead to the suspension of the partner and removal from the partner's list.
- 12. Partners must adhere to zoom guidelines during every meeting for example;
  - Registered names must be displayed on Zoom during meetings,
  - Zoom links MUST not be shared with third parties. Partners are encouraged to share their vidoes during meetings and add pictures to their profiles for easy identification.
  - Inappropriate dressing is not allowed during meeting such as night wear, lingerie and singlets for men
- 13. Partners WhatsApp group are restricted to GMPM related postings only. Information shared on the group MUST not be shared elsewhere. Failure to adhere to this will attract penalties
- 14. It is MANDATORY for partners to contribute at least 10% or minimum of 5% of their tithe to the ministry. Each Glorious Generation Group manages their project's finances, and it is REQUIRED partners to make contributions towards these projects either monthly or adhocs to fulfil the financial obligations of each group.
